Technical Bids will be opened immediately after the bid submission deadline on 25 October 2022 at 71, C-3 Gulberg III, Lahore (new building address) in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas the financial bids of those bidders whose technical bids are not responsive and qualified shall be returned unopened.
