- The Islamic Republic of Pakistan has applied for financing from the Asian Development Bank (ADB) toward the cost of Developing Resilient Environments and Advancing Municipal Services in Punjab Project. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The Housing, Urban Development & Public Health Engineering Department (HUD&PHED), Government of the Punjab, represented by Rawalpindi Water and Sanitation Agency, Rawalpindi (R-WASA) ("the Employer") invites sealed bids from eligible Bidders for the Lot/Lots as mentioned above ("the Works"). Bidders may submit their bid for one or more Lot(s) or any combination of Lots. However, a Bidder may be awarded one or multiple Lots if it submits the lowest evaluated substantially responsive bid(s) provided such Bidder meets the aggregated qualification requirements for one Lot or a combination of Lots.
- Open competitive bidding will be conducted in accordance with ADB's <u>Single-Stage: One</u> <u>Envelope (1S1E)</u> without Prequalification procedure and is open to all Bidders from eligible countries as described in the Bidding Document. National Bidders must be registered with Pakistan Engineering Council (PEC) and shall have a valid registration certificate (2023) in





category-CA with specialization in CE09, CE10, ME06 and EE11 at the time of bid submission.

4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding: **(this table now reads as mentioned below)** 

Lot No.	Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one (1) contract that has been successfully or substantially completed within the <b>last Fifteen</b> (15) years and that is similar to the proposed works, where the value of the Bidder's participation in the contract exceeds the amount mentioned below for each respective lot. The similarity of the Bidder's participation shall be based on details/characteristics as described in Section 6 "Employer's Requirements for each respective lot" which requires experience in the execution of water and sanitation projects. - 6. To purchase the bidding documents in English, eligible bidders should
  - write to address above requesting the Bidding Documents for the "Works" mentioned above; and
  - pay a nonrefundable fee of PKR. 25,000 or US\$ 100 deposited through "CHALLAN FORM NO.32-A" under head of "Other Receipt CO3870" in Treasury/Sub-Treasury (National Bank of Pakistan) or (State Bank of Pakistan)" for Complete Bidding Document.
  - The document may be collected in person or may be requested via express airmail for an additional fee of PKR 5,000.00 for domestic delivery or USD 50.00 for overseas delivery with original paid "Challan form". No liability will be accepted for loss in transit or late delivery.

The eligible Bidders also have the option to download the Bidding Document at no cost from i.e., <u>www.piciip.gop.pk</u>. Eligible Bidders opting to download the Bidding Document from the aforementioned website shall inform PCU in writing at the address given above failing which PCU shall not be responsible if the bidder does not receive clarifications and amendments, if any.
