

## Invitation for Bids

1. The Islamic Republic of Pakistan has received a financing from Asian Development Bank (ADB) towards the cost of **Punjab Intermediate Cities Improvement Investment Project (PICIIP)**. It is intended that part of the proceeds of this financing will be used for payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Program Management Unit (PMU), Punjab Intermediate Cities Improvement Investment Project (PICIIP), Local Government & Community Development Department, Punjab, Pakistan** (“the Employer”) invites sealed bids from eligible Bidders for the **Procurement of Works for Rehabilitation / Improvement of Water Supply & Sewerage System in North Zone, Sialkot** (“the Works”). The Works comprise the following lots:
  - Lot 1: Sewerage Lines and Allied Works (Zone 3-A)
  - Lot 2: Pre-Cast RCC Conduits and Allied Works (Zone 3-B)
  - Lot 3: Influent Pumping station, Forcemain and Allied Works (Zone 3-C)
  - Lot 4: Water Supply System (Zone 3-D)

The Bidders may bid for one, combination, or ALL Lots.
3. **National Competitive Bidding** will be conducted in accordance with the ADB’s [Single Stage-Two Envelope](#) bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

<b>Lot No.</b>	<b>Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one (1) contract that has been successfully or substantially completed within the last ten (10) years and that is similar to the proposed works, where the value of the Bidder's participation in the contract exceeds the amount mentioned below for each respective lot. The similarity of the Bidder's participation shall be based on details/characteristics as described in Section 6 "Employer's Requirements for each respective lot" which require experience in execution of water and sanitation projects.</b>	<b>The Bidder should have minimum Average Annual Construction Turnover of Pak Rupees (PKR) as mentioned below, calculated as total certified payments received for contracts in progress or completed, within the last three (3) years for subject package:</b>	<b>The Bidder must demonstrate that it has the financial resources to meet (i) its current contract commitments and (ii) the requirement for the subject contract of:</b>

6. To purchase the Bidding Documents in English, eligible Bidders should:

- write to the address above requesting the Bidding Document for the "Works" mentioned above; and
- pay a nonrefundable fee of **PKR. 20,000** or US\$ 120 deposited through "CHALLAN FORM NO.32-A" under head of "Other Receipt CO3870" in Treasury/Sub-Treasury (National Bank of Pakistan) or (State Bank of Pakistan)" for Complete Bidding Document.

The document may be collected in person or may be sent by express airmail for an additional fee of PKR 5,000.00 for domestic delivery or USD 35.00 for overseas delivery with original paid "Challan form". No liability will be accepted for loss in transit or late delivery.

7. A pre-bid meeting for the Works shall take place at 1100 hours on Thursday, 10 September 2020 at the address mentioned above. Keeping in mind the convenience of the bidder(s), the bidder(s) can also attend the said meeting through Skype using the ID mentioned below:

- Together with a Bid Security as described in the Bidding Document.

Electronic submission of bids is not allowed.

9. Technical Bids will be opened immediately after the bid submission deadline on Monday, 28 September 2020 in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas, the financial bids of those bidders whose technical bids are not responsive and qualified shall be returned unopened.
