The addendum shall be read and construed as an integral part of the Bidding Documents and shall take precedence in case of any conflict / ambiguities in the Bidding Documents and other provisions within. The changes mentioned herein below are applicable for Contract No: NCB-Works/PICIIP-11, unless indicated otherwise.

1. Section 3: Evaluation and Qualification Criteria

(i) Table of Criteria: 1. Evaluation:

Para 1.7 "Other Criteria" is added at the end of Section 1 of the Table of Criteria.

2. Section 4 - Bidding Forms

(i) Bill of Quantities: B. Work Items:

The first line at serial number 1 is amended as follows:

3. Section 5 - Eligible Countries

(i) "Niue" has been added to the list of the countries in Section 5 of the Bidding Documents. Therefore, the total number of Eligible Countries in Section 5 is now 68.
