- 3. The PMU, PICIIP hereby invites EOI from reputed international firms and/or in association with national firms. The consultants will be recruited using the Full Technical Proposal procedure based on the Quality and Cost-Based Selection (QCBS) method and in accordance with "ADB's Guidelines on the Use of Consultants by ADB and its Borrowers (2013, as amended from time to time)".
