2. The Program Management Unit (PMU), Punjab Intermediate Cities Improvement Investment Project (PICIIP), Local Government \& Community Development Department, Punjab, Pakistan ("the Employer") invites sealed bids from eligible Bidders for the Procurement of works for SahiwalWater and Sanitation ("the Works"). The Works comprise the following lots:

- Lot 1: Water supply system, filtration plants, tubewells, OHRs, SCADA and allied works
- Lot 2: North Zone A (Sanitation) Trunk main sewer lines and allied works
- Lot 3: North Zone B (Sanitation) Trunk main sewer Conduit, Influent pumping station and allied works
- Lot 4: South Zone Trunk main sewer, Effluent pumping station and allied works Bidders may bid for one, combination, or ALL lots.

3. National Competitive Bidding will be conducted in accordance with the ADB's Single Stage-Two Envelope bidding procedure and is open to all eligible Bidders as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:

Technical Bids will be opened immediately after the bid submission deadline on Monday, 15 June 2020 in the presence of Bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas, the financial bids of those bidders whose technical bids are not responsive and qualified shall be returned unopened.
