#### **Summary of Scope:**

The impact, outcome, and the prime objective of the project is as under:

- a. The Project is aligned with the following impacts: living standards, health, and economy in Sialkot and Sahiwal improved.
- b. The Project will have the following outcome: access to quality urban services by the residents of Sialkot and Sahiwal cities improved.
- c. The prime objective of the Project is sustainable urban development through optimization of enhanced service delivery to 100% urban population living in urban area

The Project requires to recruit the ODBM Consultant (the Consultant) to provide technical and operational/management support to the municipal corporations. The consultant will assist the

municipal corporations of Sialkot and Sahiwal in (i) developing business model (set-up costs, operating cost, revenue sources, etc.) for sustainable municipal services;

(ii) improving provision of municipal services to customers by utilizing the infrastructure developed in these cities under the ADB financed L3562 (PAK); and (iii) enhancing human resource management and productivity.

The consultancy assignment/project is divided into five major outputs spanning over 30 months of Consultant's engagement with the Project. The first 18 months' input will be on the continuous basis whereas only the intermittent input of 2 months will be required in the remaining 12 months of contract with the Consultant. The Consultant's activity roadmap spanning 30 months is summarized in Figure 1 below:
